With the recent surge of Covid cases locally, the DACHS board of directors decided on Jan. 7 to not have an in-person awards banquet this year. The decision follows many other organizations now cancelling or postponing events that gather crowds together in small spaces. For instance, the Pat Garrett Festival for next month and the 50th anniversary event for the Rio Grande Historical Collection are both postponed.

HOWEVER, we will still give out the DACHS awards and recognition certificates. The plan is to contact the selected individuals and organizations and make the presentations informally. The board will then put together a recording of those presentations, along with supporting photographs, and make it available for all to see on the web. We will post it on

If all goes well, this will be accomplished by the end of January. We will email a link to the video to our membership when it is ready.

The awards for 2022 include:

- ☞ *Old Timer's Award* to be given to recognize the boundary markers between Mexico and the United States in Doña Ana County;
- ☞ *Historically Significant Building Worthy of Preservation* to be given to St. James Episcopal Church, completed in 1912;
- ☞ *Hall of Fame Award* to David Soules;
- ☞ *Heritage Award* to Evan Davies;
- ☞ *Pasajero Del Camino Real Award* to David Thomas for *The Trial of Billy the Kid*;
- ☞ *Gemoets Prize for Best Article in the 2022 Review* to Dylan McDonald.

DACHS Hall Of Fame Filled With Local "Who's Who"

Later this month, the DACHS will induct David Soules into its Hall of Fame. So what is the Hall of Fame? According to the Society's bylaws, "the Hall of Fame Award is designed to recognize an individual chosen by the DACHS Board of Directors who is known for exceptional contributions to the preservation of the history and culture of the Mesilla Valley. The contribution should be of a substantial nature and be evidenced by enduring and observable worth to the Doña Ana County Historical Society and the community at large."
