President's Comments

The responses to the survey last year indicated that the membership wanted more field trips. The board has discussed this and produced a number of ideas. The first comes from an informal poll conducted at the last membership meeting. A number of members have never been to Fort Cummings. A smaller number did not know where Fort Cummings is located. So our first field trip will be to Fort Cummings. The fort is located a few miles north of highway 26 between Hatch and Deming.

The fort was established in 1862 and construction started the next year. The fort was located near Cooke's Spring to quell Indian depredations in the vicinity. Indeed the area around the fort and on the Butterfield Trail was the most dangerous in the whole 2900 miles of the trail. A Butterfield station was built near the spring in 1858. The foundation remains of the station and part of the fort can still be seen. George Hackler will give a short talk about the history of the area.

We can drive to the location. Four wheel drive is not required however more clearance than the family sedan has, will be needed. On June 11th at 9:00am, the caravan will assemble at the Pan American Center in the east side of the east parking lot. Wear a brimmed hat, good walking shoes, bring a lunch and extra water. The important remains can be see within a short level walk.

Doug Hamilton received the Ph.D. degree in Electrical Engineering from Stanford University, and was for 30 years Professor of Electrical and Computer Engineering at The University of Arizona. His research included digital circuit design, integrated circuit design and fabrication, and electronic packaging engineering.

Since retiring he has been doing research on Southwestern history. He was a member of the team that rephotographed

Gustaf Nordenskiöld's scenes at Mesa Verde National Park, for the *Nordenskiöld Centennial* in 1990.

Doug is co-author of several textbooks, of *Photographing Mesa Verde: Nordenskiöld and Now*, a book in the Mesa Verde Centennial Series, and the monograph *Military Debacle in Cottonwood Wash: the Apache Ambush of Captain Frank Millar and Assistant Surgeon Benjamin Tappan, Jr.* He is currently working on a series entitled *It Happened Here*; video documentaries and history slide shows filmed at the locations of historic events. His video *Escape of the Apache Kid* will be shown on the Pinal County cable channel.

Doug is a member of the Tucson Corral of Westerners International.

in 1887 he and other scouts were involved in a fracas at the army post at San Carlos, Arizona Territory. They were arrested, tried in court in Globe, and Kid was

unjustly found guilty of assult with intent to commit murder. With 8 other prisoners he was being taken by stagecoach from Globe to Casa Grande; all would then be taken by train to Yuma Territorial Prison. Gila County Sheriff Glen Reynolds and Deputy Holmes escorted the party. About 60 miles north

of Tucson and four miles west of Riverside, the prisoners attacked and killed Reynolds and Holmes, and escaped into the desert. All except the Apache Kid were eventually killed or captured.

In this presentation Doug describes events leading up to the trial, and discusses the escape, the events that occurred afterward, and what became of the Kid. Images of the principal participants and the escape site are shown.

Martha Shipman Andrews is an At-Large member of the Historical Society Board of Directors and the Editor of the *Southern New Mexico Historical Review*. She is also the New Mexico State University Library archivist.

In 2008, the NMSU Library in collaboration with Rio Grande Books published the book "*The Whole Damned World: New Mexico Aggies at War 1941-1945*" by Martha Shipman Andrews.

In January 2011, the New Mexico Book Co-op announced their list of the 100 Best New Mexico Books, in time for the New Mexico Centennial in 2012. In-

cluded on that list was "The Whole Damned World" edited by Andrews, with an introduction by Richard Melzer of the University of New Mexico-Valencia.

"The Whole Damned World" consists of approximately 250 letters written to NMSU Dean of Engineering Daniel B. Jett by former students serving in all branches of the services and every theater of World War II. The entire collection of 5,000

letters is held by the Archives and Special Collections Department of the NMSU Library.

"The Whole Damned World" was previously awarded the New Mexico History Book Award, the first-ever Best New Mexico Book Award, and the Caliente Award from Reading New Mexico.

2011 Award Series

At the Annual Banquet held the 29th of January, the Society's Awards Committee presented several awards. With this issue, we start featuring some photos and the award stories for various people and/or places honored with awards.

THE OLD TIMERS AWARD

Identifying a cherished object, natural phenomenon, or cultural tradition prominent in the Mesilla Valley. The Las Cruces City Hall Lions "E.J. and Mable"

For more than 40 years, two bronze lions have guarded Las Cruces' City Hall, first at the original location on Church Street and now at the parking entrance of the new City Hall downtown. They are one of many lasting legacies of Las Cruces philanthropists E.J. and Mable Stern.

E.J. Stern was born in Hungary and married his wife – she preferred the "Mable" spelling - in 1913. The Sterns moved to Las Cruces in 1917 and established the Popular Dry Goods store on Main Street. In 1926, the Sterns opened the White House, which they ran until retiring in 1946. Stern then focused on farming 1,600 acres of land and various charitable efforts. Every year at Christmas, the Sterns bought new dresses for 250 needy local girls, with Mable wrapping each gift. They gave thousands to local churches, established loan and scholarship programs for dozens of NMSU students, and donated \$60,000 toward debt and a clubhouse for the Boys and Girls Club.

In August 1968, with a new Las Cruces City Hall near done, E.J. Stern donated to the city the lion statues he had commissioned in Mexico City. The formal dedication did not occur until July 26, 1969. "I did it because I wanted to do something for the community as a whole," Stern told the Sun-News that July. The lions sat on the west entrance of City Hall, overseeing Urban Renewal, numerous parades, and the Whole Enchilada Fiesta before being rededicated in 2010, along with a time capsule from 1976, at the new City Hall.

built the Saint Joseph's Church in Mescalero, New Mexico. Anyone driving along US Highway 70 through Mescalero on the way to Ruidoso has seen the church standing prominently on the hill above the highway. Although Dorothy's book had been released when she was here, she had not received a shipment in
