SUGGESTED PROGRAMS FOR 2014

When Jon Hunner, Mary Kay Shannon, and I met in mid-December, we talked about the benefits to the Society of collaborating with other history and historic preservation groups in the area, such as Human Systems Research, the Ft. Seldon preservationists, and Mesilla Valley Preservation Inc. and inviting them to bring the DACHS up to date on their successes and challenges and to tell us if and how we could help. We also mentioned having Richard Sims, Director of the State Monuments Division of the NM Department of Cultural Affairs, as a speaker and of exploring new light brought to local mysteries such as the Fountain murders and the recently uncovered tintype photograph of Dan Dedrick and another person, possibly Billy the Kid.

So to begin the New Year's programs, our February 20, 2014, speakers will be Karl Laumbach, Associate Director at Human Systems Research, and Toni Laumbach, Associate Director at the New Mexico Farm and Ranch Museum, a husband and wife team presenting on the Cañada Alamosa excavation project which is currently on exhibit at the Farm and Ranch Museum under the title "The Cañada Alam-

osa: 4000 Years of Agricultural History." Cañada Alamosa is an isolated river canyon with pit-house and pueblo ruins, Apache camps, and 19th and 20th century homesteads of Hispanic and Anglo settlers. The sites span a time period from about A.D. 600 to A.D. 1400 and are located on private land in south central NM, in Socorro and Sierra Counties, near the Town of Monticello. The excavation project began in 1999 under the leadership of Karl Laumbach, project archaeologist.

Mark the date and details will follow in the February Newsletter.

Mary Kay, who is to me an entire library of New Mexico History and beyond, has agreed to serve as the Chair of the Awards Committee. If you have program ideas or award suggestions, please let her know.
