.Field Trip to Dripping Springs

Located east of Las Cruces, the Dripping Springs Resort was built by Col. Eugene Van Patten in the 1870's. Holding 16 rooms, a large dining room and concert hall the resort in its spectacular setting was a natural attraction for people. The site later became a tuberculosis sanitarium.

Today, the BLM oversees the Dripping Springs Natural Area. Dan Aranda, a volunteer for the BLM and longtime DACHS member has agreed to lead a tour of this historic site in the fall. We will keep you informed as the date is set.

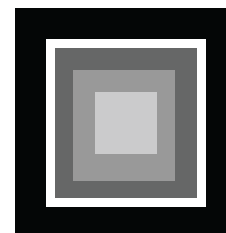

Amador – Courthouse Update

The State has approved the sale of the Courthouse to Amador Associates LLC for conversion to condominium apartments as reported in the last newsletter. The future of the Amador is still undecided as there were two proposals in addition to the one submitted to the County by DACHS on 3/31/06. Brian Haines, the County Manager is responsible for recommending disposition of the building to the County Commission but he has not responded to a request relative to the status of this historic building nor has the Advisory Committee been contacted. The County has moved most of their offices to their new facility.
