Amador Report Disappoints

In consideration of one of our primary ob-jectives, to preserve our local history, the Soci-ety advocated the establishment of a history mu-seum utilizing the old Amador Hotel. The prop-erty was transferred from the County to the City of Las Cruces specifically for that purpose. A study was performed to determine the basic con-dition of the adobe structure which was found to be in remarkably good condition. The state leg-islature, in 2007 and 2008, appropriated \$170,000 to plan and preserve the Amador for use as a his-

Armijo-Gallagher House Status Report

Efforts are underway to preserve one of Las Cruces' most valuable historic treasures, the Armijo-Gallagher House, located on Amador Avenue just north of Citizens Bank of Las Cruces. Nestor Armijo, a freighter and early Las Cruces businessman, built the two-story Victorian-style adobe sometime around 1880. It was one of the first buildings in Las Cruces placed on both the state and national registers, and in 1967 was the first structure listed by the Dona Ana County Historical Society as a Building Worthy of Preservation.

The Armijo-Gallagher House has witnessed Las Cruces change from a small dusty town of 2,000 hearty souls to a city of 90,000, and it survived the Urban Renewal of the late 1960s that saw the demolition of hundreds of homes, businesses, and structures within the downtown core. Over the past 130 years, having served as a home for four generations of Armijos and later as a commercial property, it has maintained much of its structural and historical integrity. But it is now showing its age, with some of its exterior walls cracking due to water damage.

The Armijo-Gallagher House's owner Amador Bancshares, which also owns Citizens Bank, has met with various parties this year, including the newly-formed Mesilla Valley Preservation non-profit, who have expressed an interest in preserving the building. Although other major preservation projects are ongoing, particularly the Amador Hotel just down the road, local historic preservationists are urging a community effort to save a property unique to Las Cruces and its history. ■

tory museum. An Albuquerque architectural firm, Kells & Craig, was contracted by the City to develop an adaptive reuse plan to be used to facilitate achieving our objective. A final report was presented to the City Council last month with recommendations that

were unanimously approved. I am sorry to report that the original objective, to develop a history museum, is no longer being considered. Instead the property is to be developed, in several phases, as an event center with a restaurant/bar addition. Several rooms will be dedicated to the history of the Amador Hotel and the Amador family. The projected cost to complete this plan is between 8 and 11 million dollars.

I am disappointed that there is no alternative plan for a history museum and have several concerns related to the basic premise of the final plan. These are my personal views, not those of DACHS, or the Amador Museum Foundation. First, the redirection of the study resulted from the conclusion of the study team that there was insufficient community support

for a history museum and that museums of that sort were the least visited of all museums. This conclusion was based upon 30 interviews with persons selected by the team. That is an incredibly insignificant sampling of a community of 90,000 people. Follow-up meetings were never advertised by the study team, the city or the Amador Foundation. Second, the arrangement between the Foundation and the City of Las Cruces is unrealistic. The Foundation is to raise all of the development funds but is constrained by conflicting City policies regarding the State Legislature. Last, I see the use of the Amador, primarily as an event center, in competition with the City's new convention center due to be completed in 2010. ■
